First Review of CSRC's Application for Administrative Licensing (No. 200037)

(hereinafter referred to as the "Feedback").

After receiving the Feedback, Offeror has carefully discussed with the

intermediaries on the issues listed in the Feedback, verified and implemented the

issues as replied by the CSRC, and responded to the issues involved in accordance

with the requirements of the Feedback. Detailed information can be found in [Reply

http://www.cninfo.com.cn on the same day. The reply materials on the Feedback will

exemption from the tender offer obligation, and there is still uncertainty as to whether
