LETTER FROM THE BOARD

董事會函件

Dear Shareholders,

On behalf of the board (the “**Board**”) of directors (the “**Director(s)**”) of Yuk Wing Group Holdings Limited (the “**Company**”) and its subsidiaries (collectively referred to as the “**Group**”), I would like to present the 2025/26 annual report of the Group for the year ended 31 March 2026.

REVIEW

For the year ended 31 March 2026 (the “**Year**”), the Group’s revenue was approximately HK\$178.2 million (2025: approximately HK\$217.1 million). The decrease in revenue is primarily caused by the decrease of construction works and projects available during the Year when compared with the year ended 31 March 2025, resulting in a lower than expected demand for our products.

The Group recorded a net loss of approximately HK\$4.1 million for the Year (2025: net loss of approximately HK\$12.2 million). The reduction in loss was mainly due to combined effect of decrease in revenue and gross profit, as well as better cost control and less impairment is recognised during the Year.

PROSPECTS

During the Year, the Group continued to develop its various business and geographical segments. In Hong Kong, the business environment had remained stagnant due to the uncertain economic outlook.

Looking ahead, the Group maintains a highly cautious stance regarding the near future of the Hong Kong construction market. Nevertheless, the Group will continue to advance its diverse business lines and expands its geographical reach amid shifting market dynamics. In particular, the Group remains committed to the mainland China market. The management intends to actively explore new business opportunities and leverages its technical solutions to rebuild and strengthen its footprint in the PRC region.

APPRECIATION

Lastly, I would like to express our sincere gratitude to our shareholders, customers and business partners for their continuous support, and to our management and staff members for their diligence, dedication and contribution to the growth of the Group.

本人謹代表煜榮集團控股有限公司（「**本公司**」）及其附屬公司（統稱「**本集團**」）董事（「**董事**」）會（「**董事會**」）呈報本集團截至二零二六年三月三十一日止年度的二零二五／二六年報。

回顧

截至二零二六年三月三十一日止年度（「**本年度**」），本集團收益約為178.2百萬港元（二零二五年：約217.1百萬港元）。收益減少主要由於與截至二零二五年三月三十一日止年度相比，於本年度的建築活動及可施工項目數量減少，使得對我們產品的需求低於預期。

本集團於本年度錄得淨虧損約4.1百萬港元（二零二五年：淨虧損約12.2百萬港元）。虧損減少主要由於收入及毛利下降，加上較佳的成本控制及本年度確認的減值較少之綜合影響所致。

前景

於本年度，本集團繼續發展其多個業務及地區分部。於香港，由於經濟前景不明朗，營商環境持續停滯。

展望未來，本集團對香港建築市場之近期前景維持高度審慎之態度。儘管如此，本集團將繼續在瞬息萬變的市況中推進其多元業務線，並拓展地域覆蓋。尤其是，本集團一如既往致力於中國內地市場。管理層擬積極發掘新業務機遇，並利用其技術解決方案，以重建及鞏固本集團於中國地區之業務佈局。

BUSINESS REVIEW

The Group is principally engaged in the manufacturing and trading of DTH rockdrilling tools, trading of piling and drilling machineries and rockdrilling equipment.

Hong Kong remains the Group's major market, where revenue generated from Hong Kong contributed to approximately HK\$169.0 million for the Year (2025: HK\$196.3 million), representing 94.8% of total revenue (2025: 90.4%). Revenue from Macau was HK\$1.4 million (2025: HK\$1.7 million). At the international level, Scandinavia contributed HK\$2.0 million (2025: HK\$1.0 million), representing 1.1% of total revenue (2025: 0.5%). The PRC market showed significant decrease to HK\$3.8 million (2025: HK\$15.1 million).

During the Year, the market environments has been sluggish and decrease in rockdrilling projects available in the Hong Kong market. At the international level, the revenue generated from the Scandinavia market has increased during the Year as a result of the increase in business activities in the region. Businesses from China has seen decrease in activities, leading to decrease in revenue contributed from the regions. This had resulted in a decrease in contribution to our Group's revenue as our local customers have decreased their purchases of our products. There have been decreases in fair value gain in financial assets at fair value through profit or loss, where the fair value gain amounted to approximately HK\$3.4 million during the Year (2025: fair value gain of approximately HK\$7.0 million), write down of inventories of approximately HK\$1.4 million (2025: approximately HK\$3.0 million), and reversal of impairment loss of trade receivables of approximately HK\$0.8 million (2025: impairment loss of trade receivable approximately HK\$5.9 million) during the Year. The effects as mentioned above have resulted in a decrease in the loss position during the Year, where the loss for the Year is approximately HK\$4.1 million, as compared with the loss of approximately HK\$12.2 million for the year ended 31 March 2025.

業務回顧

本集團主要從事製造及買賣潛孔鑿岩工具、買賣打樁機及鑽機和鑿岩設備。

香港仍為本集團的主要市場，其中於本年度在香港產生的收益約為169.0百萬港元（二零二五年：196.3百萬港元），佔總收益94.8%（二零二五年：90.4%）。澳門產生的收益為1.4百萬港元（二零二五年：1.7百萬港元）。於國際層面，斯堪的納維亞半島貢獻2.0百萬港元（二零二五年：1.0百萬港元），佔總收益1.1%（二零二五年：0.5%）。中國市場顯著下降至3.8百萬港元（二零二五年：15.1百萬港元）。

本年度內，市場環境持續低迷，香港市場的鑿岩項目減少。於國際層面而言，由於斯堪的納維亞市場的業務活動增多，我們自該地區產生的收益於本年度有所增多。中國的業務活動減少，使得該地區貢獻的收益減少。由於我們的本地客戶減少對我們產品的購買，從而對本集團收益的貢獻減少。透過損益按公平值入賬之金融資產之公平值收益減少，於本年度，公平價值收益約3.4百萬港元（二零二五年：公平值收益約7.0百萬港元），於本年度撇減存貨約1.4百萬港元（二零二五年：約3.0百萬港元），及貿易應收款項減值虧損撥回約0.8百萬港元（二零二五年：貿易應收款項減值虧損約5.9百萬港元）。上述影響令本年度虧損狀況有所改善，本年度虧損約4.1百萬港元，而截至二零二五年三月三十一日止年度則虧損約12.2百萬港元。

Manufacturing and Trading of DTH Rockdrilling Tools

The Group is principally engaged in the manufacturing and trading of DTH rockdrilling tools. Our self-designed and manufactured DTH rockdrilling tools can be categorised into the following main categories, namely DTH hammers, casing systems (comprising driver bits and casing bits), and other miscellaneous products including button bits and bit openers, as well as our newly developed products, drill pipes, cluster drills and casing tubes. Revenue from the manufacturing and trading of DTH rockdrilling tools contributed to approximately 97.1% of the total revenue during the Year (2025: approximately 98.1%).

Trading of Piling and Drilling Machineries and Rockdrilling Equipment

The Group is also engaged in the trading of piling and drilling machineries and rockdrilling equipment to our customers as part of our technical rockdrilling solutions. Revenue from trading of piling and drilling machineries and rockdrilling equipment contributed to approximately 2.9% of the total revenue during the Year (2025: approximately 1.9%).

FINANCIAL REVIEW

Revenue

Group revenue decreased 17.9% to HK\$178.2 million (2025: HK\$217.1 million), driven primarily by Hong Kong and PRC market remains competitive. The decrease in revenue is primarily caused by the decrease of construction works and projects available during the Year when compared with the year ended 31 March 2025, resulting in a lower than expected demand for our products.

Gross Profit and Gross Profit Margin

Gross profit decreased 7.5% to HK\$40.5 million, though gross margin slightly increased to 22.7% (2025: 20.2%) due to product mix changes and pricing strategy.

製造及買賣潛孔鑿岩工具

本集團主要從事製造及買賣潛孔鑿岩工具。我們自主設計及製造的潛孔鑿岩工具主要分為以下類別：潛孔錘、套管系統（包括驅導鑽頭及套管鑽頭）及其他雜項產品（包括球齒鑽頭及擴孔器）以及新開發產品、鑽桿、叢式鑽具及套管。製造及買賣潛孔鑿岩工具的收益佔本年度總收益約97.1%（二零二五年：約98.1%）。

買賣打樁機及鑽機和鑿岩設備

本集團亦從事根據鑿岩技術解決方案向客戶買賣打樁機及鑽機和鑿岩設備。於本年度來自買賣打樁機及鑽機以及鑿岩設備的收益佔本年度總收益約2.9%（二零二五年：約1.9%）。

財務回顧

收益

本集團的收益減少17.9%至178.2百萬港元（二零二五年：217.1百萬港元），主要由於香港及中國大陸市場持續競爭。收益減少主要由於與截至二零二五年三月三十一日止年度相比，於本年度的建築活動及可施工項目數量減少，使得對我們產品的需求低於預期。

毛利及毛利率

毛利減少7.5%至40.5百萬港元，但由於產品組合變化及定價策略，毛利率輕微增加至22.7%（二零二五年：20.2%）。

Other gains and losses

The Group recorded net other gains of HK\$1.8 million (2025: net other gain of HK\$5.3 million), primarily from favorable fair-value changes in financial assets. As of 31 March 2026, listed securities fair value was HK\$30.7 million (2025: HK\$27.3 million) and the write down of inventories of approximately HK\$1.4 million (2025: write down of approximately HK\$3.0 million) during the Year.

Fair value changes of financial assets at fair value through profit or loss and securities investment

As at 31 March 2026, the fair value of the listed securities held by the Company amounted to approximately HK\$30.7 million (31 March 2025: approximately HK\$27.3 million). Dividend income of approximately HK\$1.4 million were received from the investment of listed securities during the Year (2025: approximately HK\$1.3 million). Save as disclosed in this report, there was no other additional acquisition or disposal of listed securities during the Year.

The Group regularly monitors its investment performance and make appropriate investment decisions regularly. In addition, the Group would allocate part of its idle resources from time to time to purchase principal-guaranteed wealth management products to increase its overall return.

Selling and Distribution Expenses

The Group's selling and distribution expenses decreased by approximately 12.3% to approximately HK\$10.0 million for the Year (2025: approximately HK\$11.4 million), mainly due to decrease in freight, transportation, and storage costs.

Administrative Expenses

The Group's administrative expenses decreased by approximately 15.6% to approximately HK\$38.2 million for the Year (2025: approximately HK\$45.3 million), primarily due to tighter control over operational costs.

其他收益及虧損

本集團錄得其他收益淨額1.8百萬港元(二零二五年:其他收益淨額5.3百萬港元),主要由於金融資產有利的公平值變動。於二零二六年三月三十一日,上市證券公平值為30.7百萬港元(二零二五年:27.3百萬港元),以及於本年度撇銷存貨約1.4百萬港元(二零二五年:撇銷約3.0百萬港元)。

透過損益按公平值入賬之金融資產之公平值變動及證券投資

於二零二六年三月三十一日,本公司持有的上市證券公平值約為30.7百萬港元(二零二五年三月三十一日:約27.3百萬港元)。於本年度自上市證券投資收到股息收入約為1.4百萬港元(二零二五年:約1.3百萬港元)。除本報告所披露者外,於本年度概無其他額外上市證券收購或出售事項。

本集團定時監察其投資表現,並定時作出適合的投資決定。此外,本集團將不時分配部分其閒置資源購買本金擔保的理財產品,以提高其整體回報。

銷售及分銷開支

本集團的銷售及分銷開支減少約12.3%至本年度約10.0百萬港元(二零二五年:約11.4百萬港元),主要由於運費、交通及儲存成本減少所致。

行政開支

本集團的行政開支減少約15.6%至本年度約38.2百萬港元(二零二五年:約45.3百萬港元),主要由於對營運成本收緊控制所致。

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2026, the Group's total cash and cash equivalents amounted to approximately HK\$20.8 million (31 March 2025: approximately HK\$42.2 million). As at 31 March 2026, the Group had no bank borrowings (31 March 2025: approximately HK\$5.0 million) with variable interest rate, which were repayable within one year and were guaranteed by the Company. As at 31 March 2026, the Group's other borrowing of HK\$6.0 million (31 March 2025: approximately HK\$8.0 million) was repayable within one year, which was unsecured. As at 31 March 2026, the Group's other borrowing were denominated in Hong Kong dollar (31 March 2025: bank borrowings and other borrowings were denominated in Hong Kong dollar).

The gearing ratio of the Group as at 31 March 2026 (defined as the Group's total interest-bearing liabilities divided by the Group's total equity) remained steady and was approximately 12.2% (31 March 2025: approximately 9.6%).

TREASURY POLICIES

The Group adopts a treasury policy that aims to better control its treasury operations and lower its borrowing cost. As such, the Group endeavours to maintain an adequate level of cash and cash equivalents to address short-term funding needs. The Board also considers various funding sources depending on the Group's needs to ensure that the financial resources have been used in the most cost-effective and efficient way to meet the Group's financial obligations. The deposits of the Group at various licensed banks have been and will continue to be conducted in accordance with the Group's treasury policy. The Board reviews and evaluates the Group's treasury policy from time to time to ensure its adequacy and effectiveness.

CAPITAL STRUCTURE

As at 31 March 2026, the Company's issued share capital was HK\$45,600,000 and the number of its issued ordinary shares was 456,000,000 of HK\$0.1 each.

FUTURE PLANS FOR MATERIAL INVESTMENT AND CAPITAL ASSETS

As at 31 March 2026, save as those disclosed in this report, the Group did not have plan for material investment and capital assets.

SIGNIFICANT INVESTMENTS HELD

As at 31 March 2026, the Group had no bank borrowings (31 March 2025: approximately HK\$5.0 million) which were guaranteed by the Company.

As at 31 March 2026, the Group did not enter into any material off-balance sheet transactions (2025: Nil).

CASH FLOW MANAGEMENT AND LIQUIDITY RISK

The Group's objective regarding cash flow management is to maintain a balance between continuity of funding and flexibility through a combination of internal resources, bank borrowings, and other debt or equity securities, as appropriate. The Group is comfortable with the present financial and liquidity position, and will continue to maintain a reasonable liquidity buffer to ensure sufficient funds are available to meet liquidity requirements at all times.

DISCLOSEABLE TRANSACTION IN RELATION TO TENANCY AGREEMENT

On 21 January 2026, the Company entered into a tenancy agreement (the "Tenancy Agreement") with The Center (65) Limited as the Landlord for the leasing of the office at The Center for a term of one year at the monthly rent of HK\$1.0 million.

Details of the transaction contemplated under the Tenancy Agreement are set out in the announcements of the Company dated 21 January 2026 and 28 January 2026.

EVENTS AFTER THE YEAR

On 27 April 2026 and 4 May 2026, the Company disposed an aggregate of 101,500 shares in BOC Hong Kong (Holdings) Limited (“**BOC Hong Kong**”) for an aggregate consideration of approximately HK\$4,538,000 (exclusive of transaction costs) in a series of transactions on the open market (the “**Initial Disposals**”).

On 6 May 2026, the Company further disposed an aggregate of 48,500 BOC Hong Kong shares for an aggregate consideration of approximately HK\$2,185,000 (exclusive of transaction costs) in a series of transactions on the open market (the “**Final Disposals**”).

As the Final Disposals took place within a 12-month period from the date of the Initial Disposals, the disposal when aggregated of the Initial Disposals and the Final Disposals (the “**Disposal**”), constituted a discloseable transaction of the Company and was subject to the reporting and announcement requirements under Chapter 14 of the Listing Rules.

Details of the Disposal are set out in the announcements of the Company dated 15 May 2026 and 3 June 2026.

On 12 June 2026 Top Standard Limited, a wholly-owned subsidiary of the Company (the “**Purchaser**”), Mr. Fang Haibo (the “**Vendor**”) and Mr. He Zhangxiang and Mr. He Xuebing (collectively the “**Grantors**”) entered into a sale and purchase agreement (the “**Sale and Purchase Agreement**”), pursuant to which the Purchaser conditionally agreed to acquire, and the Vendor conditionally agreed to sell the registered and paid-up share capital (the “**Sale Share Capital**”), representing 65% equity interest in 安徽潤升電力技術有限公司 (Anhui Runsheng Electric Power Technology Co., Ltd.) (the “**Target Company**”) at the total consideration of RMB37.5 million (the “**Acquisition**”).

Each of the Grantors grants to the Purchaser the option for the acquisition of the remaining 35% equity interest of the Target Company at a total nominal consideration of RMB2.0 (the “**Call Option**”). The Purchaser may, at any time within twelve (12) months following the completion date, exercise all or part of the Call Option at the total exercise price of RMB20.1 million.

As the Acquisition constitutes a major transaction for the Company and was subject to the reporting, announcement, circular and shareholders' approval requirements under Chapter 14 of the Listing Rules. And hence ordinary resolutions will be proposed at an extraordinary general meeting of the Company to approve the Acquisition.

Details of the Acquisition are set out in the announcement of the Company dated 12 June 2026.

FOREIGN EXCHANGE RISK

Our Group's operations are mainly in Hong Kong and the People's Republic of China (the "PRC"), and most of the operating transactions, revenue, expenses, monetary assets and liabilities are denominated in Hong Kong dollars and Renminbi. As such, the Directors are of the view that the Group's risk in foreign exchange is insignificant and that we should have sufficient resources to meet foreign exchange requirements as and if it arises. The Group has not engaged in any derivative to hedge its exposure to foreign exchange risk.

EMPLOYEES AND REMUNERATION POLICIES

As at 31 March 2026, the Group had approximately 87 employees (31 March 2025: approximately 101 employees) in Hong Kong and the PRC. The Group's remuneration policy is reviewed periodically and determined by reference to market terms, company performance, and individual qualifications and performance. Other staff benefits include bonuses awarded on discretionary basis, mandatory provident fund scheme for Hong Kong employees, and state-sponsored retirement plans for PRC employees. The Group also offers a variety of training schemes to its employees.

COMPLIANCE OF THE CG CODE

The Company focuses on maintaining a high standard of corporate governance for purposes of enhancing the value for its shareholders and protecting their interests. The Company has adopted the code provisions (the “**Code Provisions**”) set out in the Corporate Governance Code (the “**CG Code**”) contained in Appendix C1 to the Listing Rules and has set up a series of corporate governance measures. The Company has complied with the applicable Code Provisions set out in the CG Code during the Year except for the Code Provision of C.2.1.

In accordance with Code Provision C.2.1, the roles of chairman and chief executive should be separated and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing. Ms. Woo Lan Ying has been the chief executive officer of the Company since 2 July 2024. The Company currently does not have any officer with the title of chairman. The functions of chairman were performed by the Executive Directors. Notwithstanding the aforementioned, the Board will review the current structure from time to time and as and when appropriate if candidate with suitable leadership, knowledge, skills and experience is identified, the Company may make the necessary modification to the management structure.

The Board will examine and review, from time to time, the Company's corporate governance practices and operations in order to meet the relevant provisions under the Listing Rules and to protect the shareholders' interests.

CORPORATE PURPOSE, VALUE, STRATEGY AND CULTURE

The Board leads and promotes to establish and continually reinforce the desired corporate culture of the Company which is underpinned by our corporate values of committing high standard of business ethics and integrity. Our sound corporate culture reaches all levels of the Group, and aligns with the Company's missions, corporate values and strategies. We adhere to the principles of fairness, impartiality, integrity and honesty, and focus on innovative services and responsible operations as our main business strategy.

On 23 January 2026, the Company appointed Mr. Todd Eric as an Independent Non-executive Director and a member of each of the Audit and Compliance Committee, the Remuneration Committee and the Nomination Committee. From which, the Company complied with the requirements under Rules 3.10(1) and 3.10(A) of the Listing Rules.

Save as disclosed above, during the Year, the Company has at least three Independent Non-executive Directors, representing at least one-third of the Board, with at least one Independent Non-executive Director possess professional qualifications or accounting knowledge or related finance management expertise as required under Rules 3.10(1), 3.10(2) and 3.10A of the Listing Rules. The Board believes there is sufficient independence element in the Board to safeguard the interest of Shareholders.

Confirmation of independence

After taking into consideration of the factors regarding the evaluation of the independence of the Independent Non-executive Directors pursuant to Rule 3.13 of the Listing Rules, and the annual written confirmation of independence given by each of the Independent Non-executive Directors, the Company is of the view that all Independent Non-executive Directors meet the guidelines for assessing independence set out in Rule 3.13 of the Listing Rules and are independent.

Independence mechanisms

The Company has put in place mechanisms to ensure independent views and input are available to the Board. All the Directors, including the Independent Non-executive Directors, have the right to express their views to the Board and separately and independently access to the management of the Group to make informed decisions. The Directors are entitled to seek advice from the company secretary of the Company or, upon reasonable request, seek independent professional advice at the Company's expenses to assist the Directors to discharge their duties to the Company. All Independence Non-executive Directors attended all the meetings of the Board and its relevant committees held during the Year.

Any Director or his/her associate who has a conflict of interest in a matter to be considered by the Board will be dealt with by a physical Board meeting rather than by written resolutions. Such Director will be required to declare his/her interests before the meeting and abstain from voting and not counted towards the quorum on the relevant resolutions. Independent non-executive Directors who, and whose associates, have no interest in the matter should attend the Board meeting.

The Board has reviewed and considered that the mechanisms are effective in ensuring that independent views and input are provided to the Board during the Year.

Directors' Responsibilities

The Board has an ultimate oversight of the Group's activities. Its primary functions are to set and direct the Company's strategy and to monitor and measure the management's performance. The Board is accountable for the overall strategic development of the Group with the objective to enhance shareholder value. Delegation to Management

The senior management is responsible for the specific implementation of the resolutions of the Board and of the daily business management and operations of the Group, which includes formulating (i) the Company's operating plan and investment proposal; (ii) the plan of establishing the internal management authority; (iii) the basic management system of the Company; and (iv) the Company's specific regulations. The Executive Directors and senior executives meet regularly to review the performance of the businesses of the Group as a whole, co-ordinate overall resources and make financial and operational decisions. The Board also gives clear directions as to their powers of management including circumstances where management should report back, and will review the delegation arrangements on a periodic basis to ensure that they remain appropriate to the needs of the Group.

Board Meetings

Pursuant to the Code Provision C.5.1 of the CG Code, the Board should meet regularly and Board meetings should be held at least four times a year at approximately quarterly intervals. Agenda of Board meetings are presented to the Directors for comments and approval. Each Director may include any item in the agenda. The Board is provided with adequate, timely and reliable information about the Group's business and developments before each Board meeting at which the Directors actively participate and hold informed discussions. A notice of regular board meeting shall be given to all directors at least 14 days before the meeting is convened pursuant to the requirements of the CG Code, and such notice shall state the date, time and venue of the meeting to be convened and the format to be adopted of such meeting. Other interim Board meetings have reasonable notices be delivered to all Directors.

The quorum for a Board meeting shall be the presence of two Directors. The Directors may participate in any meeting of the Board either in person or through electronic means of communications, for the purpose of counting a quorum, such participation shall constitute presence at a meeting as if those participating were present in person. The secretary of the Company's Board is responsible for preparing and safekeeping the minutes of the Board meetings and ensuring that the Directors can enquire about such minutes.

Appointment, Re-election and Removal of Directors

Code Provision B.2.2 of the CG Code stipulates that every director (including those appointed for a specific term) should be subject to retirement by rotation at least every three years.

Each of the Directors has entered into a letter of appointment with the Company. Each of them is subject to his retirement by rotation and re-election at an annual general meeting of the Company in accordance with the Articles. Pursuant to Article 83(3) of the Articles, the Board shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or as an additional to the existing Board. Any Director appointed by the Board to fill a casual vacancy or as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company respectively and shall then be eligible for re-election at the meeting in accordance with the Articles.

Pursuant to Article 84(1) of the Articles, at each annual general meeting of the Company, one-third of the Directors for the time being, shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years and, being eligible, offer themselves for re-election.

Pursuant to Article 83(5) of the Articles, the members of the Company may, at any general meetings convened and held in accordance with the Articles, remove a Director by ordinary resolution at any time before the expiration of his period of office notwithstanding anything to the contrary in the Articles or in any agreement between the Company and such Director.

Mr. Todd Eric was appointed as the Independent Non-executive Director on 23 January 2026. He confirmed prior to his appointment that he has obtained the legal advice as referred to under Rule 3.09D of the Listing Rules and also understood his obligations, duties and responsibilities of a director of the Company under the Listing Rules.

Directors' Training and Professional Development

Each newly appointed Director is provided with comprehensive induction to ensure that he/she has a proper understanding of the operations and businesses of the Group as well as the director's duties, responsibilities, and obligations under the Listing Rules and relevant regulatory requirements.

During the Year, the Directors were provided with regular updates on the Group's business and operation and the information which covered topics, including but not limited to, the CG Code, disclosure and compliance of inside information, updates and changes in relation to legislative and regulatory requirements in which the Group conducts its business, and reading materials which are relevant to their duties and responsibilities for their study and reference. During the Year, all Directors have participated in continuous professional development to develop and refresh their knowledge and skills pursuant to the Code Provision C.1.4 of the CG Code.

Our Board delegates certain responsibilities to various committees. In accordance with relevant laws, regulations, the Articles of Association and the certain rules and regulations, we have formed three board committees, namely the Audit and Compliance Committee, the Remuneration Committee and the Nomination Committee.

Audit and Compliance Committee

The Company has established the Audit and Compliance Committee with written terms of reference in accordance with Rule 3.21 of the Listing Rules and the CG Code. Following the resignation of Mr. Yiu To Wa on 16 January 2026, the Company failed to meet the composition requirement of the Audit and Compliance Committee under Rule 3.21 of the Listing Rules. Subsequent to the appointment of Mr. Todd Eric on 23 January 2026, the Company has fully complied with the composition requirement of the Audit and Compliance Committee under Rule 3.21 of the Listing Rules. The Audit and Compliance Committee currently comprises three Independent Non-executive Directors, namely Mr. Wong Siu Keung Joe (being the chairman of the Audit and Compliance Committee), Mr. Cheung Sze Ming and Mr. Todd Eric. All of them possesses the appropriate professional and accounting qualifications.

The principal duties of the Audit and Compliance Committee include, among other things, (i) recommending to the Board on the appointment, re-appointment and removal of the Company's external auditor and on its remuneration; (ii) reviewing the Company's interim and annual financial statements and other financial reports; and (iii) reviewing the Company's financial reporting system, internal control procedures (including monitoring the effectiveness of the internal audit function) and risk management system.

During the Year, the Audit and Compliance Committee held 3 meetings with the independent auditors and the senior management of the Company to consider the independence and audit scope of independent auditor, and to review and discuss the risk management and internal control systems of the Group, the effectiveness of the Company's internal audit and risk control function, consolidated interim and annual financial statements of the Group and the opinion and report of independent auditor before reporting and submitting to the Board for their approval.

Remuneration Committee

The Company has established the Remuneration Committee with written terms of reference in accordance with Rule 3.25 of the Listing Rules and the CG Code. Following the resignation of Mr. Yiu To Wa on 16 January 2026 and the appointment of Mr. Todd Eric on 23 January 2026, The Remuneration Committee currently comprises three Independent Non-executive Directors, namely Mr. Cheung Sze Ming (being the chairman of the Remuneration Committee), Mr. Wong Siu Keung Joe and Mr. Todd Eric.

The principal responsibilities of the Remuneration Committee are to establish and review the policy and structure of the remuneration for the Directors and senior management, to establish the performance evaluation standard, procedures and system, to annually evaluate the performance of the Directors and senior management, to make corresponding recommendations to the Board, and to perform other duties and responsibilities as assigned by the Board. The Remuneration Committee reviews matters relating to share schemes under Chapter 17 of the Listing Rule, if necessary.

The remuneration policy is to establish formal and transparent procedures for evaluation, determination and review of remuneration related matter of the Group. The emoluments of the Executive Directors are determined based on the skills, knowledge, individual performance as well as contributions, the scope of responsibility and accountability of such Directors, taking into consideration the Company's performance and prevailing market conditions. The remuneration policy of the Independent Non-executive Directors is to ensure that they are adequately compensated for their efforts and time dedicated to the Company's affairs including their participation in respective Board committees. The emoluments of Independent Non-executive Directors are determined with reference to their skills, experience, knowledge, duties and market trends. The remuneration of Directors and senior management is reviewed at least annually.

During the Year, the Remuneration Committee held 1 meeting to review the remuneration structure of the Directors and senior management and made recommendation to the Board for approval.

Details of the remuneration payable to members of senior management by band for the Year are set out in Note 11 to the consolidated financial statements.

Nomination Committee

The Company has established the Nomination Committee with written terms of reference in accordance with Rules 3.27A of the Listing Rules and the CG Code. With effect from 30 June 2025, Ms. Li Kai Lai Miranda has been appointed as a member of the Nomination Committee. Subsequently, following the resignation of Mr. Yiu To Wa on 16 January 2026 and the appointment of Mr. Todd Eric on 23 January 2026. The Nomination Committee currently comprises three Independent Non-executive Directors, namely Mr. Cheung Sze Ming (being the chairman of the Nomination Committee), Mr. Wong Siu Keung Joe and Mr. Todd Eric, and Ms. Li Kai Lai Miranda, the Executive Director.

The principal responsibilities of the Nomination Committee are to review the size, structure and composition of the Board and the board diversity policy adopted by the Company on a regular basis, to consider and recommend to the Board suitable and qualified candidates of the director and senior management, to review the independence of the Independent Non-executive Directors, to determine the policy for nomination of directors and to perform other duties and responsibilities as assigned by the Board.

During the Year, the Nomination Committee held 1 meeting (i) to review and consider the structure, size, diversity and composition of the Board; (ii) to assess the independence of Independent Non-executive Directors; (iii) to consider the re-election of Directors at the annual general meeting; (iv) to consider of suitable Executive director candidates for joining the Company; and (v) to recommend the aforesaid matters to the Board for approval.

BOARD DIVERSIFICATION POLICY

The Company adopted a board diversity policy (the “**Board Diversity Policy**”) since the Listing Date. With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In designing the Board’s composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

Selection of candidates will be based on a range of diversity perspectives including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

The Nomination Committee is responsible for ensuring the diversity of the Board members and compliance with relevant codes governing board diversity under the Listing Rules. The Nomination Committee and the Board will monitor the implementation of the Board Diversity Policy and review the Board Diversity Policy and the Board composition under diversified perspectives annually to ensure its continued effectiveness. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

During the Year, the Board, through the Nomination Committee, has reviewed the implementation and effectiveness of the Board Diversity Policy and the composition of the Board, and concluded that the Company had met the diversification requirements with regard to gender, age, cultural and educational background, professional experience, skills and knowledge. When making the appointment and re-appointment of Directors in the future, the Nomination Committee will nominate new Directors pursuant to the requirements of the Board Diversity Policy to achieve the objective of diversity in Board members.

Gender diversity

The Company has also taken steps to promote gender diversity at all levels of the Company, including but not limited to the Board and the management levels. During the Year and as at the date of this report, at least 1 out of the 5 Directors is female. The Board will use its best endeavour to maintain the gender diversity at the Board and at mid to senior level of the Group. The Board will maintain such gender diversity through applying its Board Diversity Policy. The Company and its Nomination Committee would take into account diversity perspectives including gender diversity in assessing potential Board member candidates. The Board is also characterized by significant diversity, whether considered in terms of gender, age, educational background, professional experience, skills, knowledge and length of service.

Gender ratio in the workforce is set out in the Environmental, Social and Governance (“ESG”) Report of the Company to be published at the same time as this annual report is published on the websites of the Stock Exchange and the Company respectively. The current gender diversity of workforce was appropriate taking into account the business models and operational needs and the Board is satisfied that the Company has achieved gender diversity in its workforce. The Group make its best endeavour to encourage gender diversity since recruitment and selection process and across its workplace.

Selection Criteria

When assessing the suitability of the proposed candidate to the Board regarding the appointment or re-appointment of any existing director(s) of the Board, the Nomination Committee should consider the following factors:

- The candidate should be of good character, integrity and competent to act as director of the Company;
- The candidate should possess qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Group’s business and corporate strategy;
- The candidate should be able to devote sufficient time to discharge duties as a Board member and other directorships and significant commitments;
- The candidates should be considered on merit, against objective criteria and with due regard to the diversity perspectives set out in the Board Diversity Policy of the Company; and
- The candidates for independent non-executive directorship should meet the “independence” criteria as required under the Listing Rules and the composition of the Board is in conformity with the provisions of the Listing Rules.

The Nomination Committee may also consider such other factors as it may deem are in the best interests of the Company and the Shareholders as a whole.

Nomination Procedures

1. The Nomination Committee shall utilise various methods for identifying candidates for directorship, including recommendations from Board members, management, and professional search firms;
2. The Nomination Committee shall consider candidates for directorship properly submitted by the Shareholders;
3. The Nomination Committee shall undertake adequate due diligence in respect of appointment of any proposed candidate to the Board, prior to making recommendations for the Board's consideration and approval;
4. The Nomination Committee shall consider and recommend to the Board the re-election of any existing Director(s) for the proposed candidates at the general meeting; and
5. The Board shall make recommendation to the Shareholders in respect of the proposed re-election of director at the general meeting.

MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the “**Model Code**”) as set out in Appendix C3 of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) as its code of conduct for regulating securities transactions by Directors. Following a specific enquiry to all Directors by the Company, all Directors have confirmed that they have complied with the required standard set out in the Model Code throughout the Year.

RISK MANAGEMENT AND INTERNAL CONTROLS

The Board and the senior management are accountable for the overall responsibility in respect of monitoring the implementation of internal control and risk management procedures and other measures in the Group. The Company's risk management and internal control system aims at managing but not eliminating the risk of not being able to achieve the business objectives. Moreover, only reasonable but not absolute warranties can be given for statements which are not materially untrue or will not result in material losses.

The Board has conducted an annual review of the effectiveness of the Company's risk management and internal control systems through discussion with the Audit and Compliance Committee. The Board believed that the Company's risk management and internal control systems are effective and sufficient, and is satisfied that the Group has fully complied with the CG Code in respect of internal controls during the Year.

We have appointed external professional advisors (including the auditor or other advisors) for provision of professional advice in respect of how we observe applicable laws and regulations.

The Board has reviewed the need for an internal audit function and is of the view that in light of the size, nature and complexity of the business of the Group, it would be more cost effective to appoint external independent professionals to perform internal audit function for the Group in order to meet its needs.

During the Year, the Group appointed BT Corporate Governance Limited ("BTCGL") to:

- assist in identifying and assessing the risks of the Group, including ESG-related risks, through a series of discussions and interviews; and
- independently perform internal control review and assess the effectiveness of the Group's risk management and internal control systems.

The results of the independent review and assessment were reported to the Audit and Compliance Committee and the Board. Moreover, improvements in internal control and risk management measures as recommended by BTCGL to enhance the risk management and internal control systems, and risk mitigating measures of the Group were adopted by the Board. Based on the findings and recommendations of BTCGL, as well as the comments from the Audit and Compliance Committee, the Board considered the internal control and risk management systems are effective and adequate.

董事會已檢討內部審計職能之需要，且認為基於本集團業務之規模、性質及複雜程度，為符合其需要，委任外部獨立專業人士為本集團執行內部審計職能更具成本效益。

於本年度，本集團委任哲慧企管專才有限公司（「企管專才」），以：

- 透過一系列討論及面談，協助識別及評估本集團之風險，包括與環境、社會及管治相關的風險；及
- 獨立進行內部監控之審閱及評估本集團之風險管理及內部監控制度的成效。

獨立審閱及評估之結果已報告予審核及合規委員會及董事會。此外，董事會已採納企管專才對內部監控及風險管理措施之改善建議，以加強風險管理及內部監控制度，並已採納減輕本集團風險之措施。基於企管專才之發現及建議和審核及合規委員會之意見，董事會認為內部監控及風險管理制度有效且足夠。

Enterprise Risk Management Framework

The Group has established its enterprise risk management framework. While the Board has the overall responsibility to ensure that sound and effective internal controls are maintained, management is responsible for designing and implementing internal control systems to manage all kinds of risks faced by the Group.

Through the risk identification and assessment processes, risks are identified, assessed, prioritised and treated. The Group's risk management framework follows the COSO Enterprise Risk Management – Integrated Framework, which allows the Board and management to manage the risks of the Group effectively. The Board receives regular reports through the Audit and Compliance Committee that oversees risk management and internal audit functions.

Risk Control Mechanism

The Group adopts a “three lines of defence model” corporate governance structure with operational management and controls performed by operations management, coupled with risk management monitoring carried out by the finance team and independent internal audit function outsourced to and conducted by BTCGL. The Group has adopted risk management policy and procedures (the “**Risk Management Policy**”) and maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Audit and Compliance Committee, and management with a profile of its major risks and records management's action taken to mitigate the relevant risks. Each risk is evaluated at least annually based on its likelihood of occurrence and potential impact upon the Group. The risk register is updated by management as the risk owners with addition of new risks and/or removal of existing risks, if applicable, at least annually, after the annual risk evaluation has been performed. This review process can ensure that the Group proactively manages the risks faced by it in the sense that all risk owners have access to the risk register and are aware of and alert to those risks in their area of responsibility so that they can take follow-up action in an efficient and timely manner.

The Group's risk management activities are performed by management on an ongoing basis. The effectiveness of the Group's risk management framework is evaluated at least annually, and periodic management meeting is held to update the progress of risk monitoring efforts. Management is committed to ensure that risk management forms part of the daily business operation processes in order to align risk management with corporate goals in an effective manner.

本集團已建立其企業風險管理框架。董事會就確保維持良好及有效的內部監控承擔整體責任，而管理層則負責設計及實行內部監控制度，以管理本集團面對之各種風險。

透過風險識別及評估程序，風險獲識別、評估、確定優先次序及處理。本集團之風險管理框架遵循COSO企業風險管理 — 綜合框架，讓董事會及管理層有效管理本集團之風險。董事會定期透過審核及合規委員會接獲報告，而審核及合規委員會負責監督風險管理及內部審計職能。

本集團採納「三道防線模式」企業管治架構，由營運管理層進行營運管理及監控，並由財務團隊進行風險管理監控，而獨立內部審計職能則外判予企管專才並由其負責進行。本集團已採納風險管理政策及程序（「**風險管理政策**」），並存置風險登記冊以記錄本集團所有已識別主要風險。風險登記冊為董事會、審核及合規委員會及管理層提供其主要風險情況，並記錄管理層為降低相關風險所採取的行動。每種風險乃根據其發生的可能性及對本集團的潛在影響至少每年進行評估。風險登記冊由管理層作為風險擁有人於進行年度風險評估後通過加入新風險及／或移除現有風險（如適用）至少每年更新一次。此檢討程序可確保本集團積極管理其所面臨的風險，就此而言，即所有風險擁有人可查閱風險登記冊並知悉及察覺於彼等負責的範圍內的該等風險，以使彼等可有效及適時採取跟進行動。

本集團之風險管理活動由管理層按持續基準進行。本集團風險管理框架的成效會至少每年予以評估，且我們會定期舉行管理層會議以更新風險監控工作進度。管理層致力確保風險管理構成日常業務營運程序的一部分，以有效地使風險管理符合企業目標。

The Company will continue to engage external independent professionals to review the Group's system of internal controls and risk management annually to further enhance the Group's internal control and risk management systems as appropriate.

Handling and Dissemination of Inside Information

The Company places a great emphasis on inside information management. For purposes of strengthening the confidentiality of inside information, maintaining the fairness of information disclosure and protecting the legal interests and rights of the vast number of investors, the Company's information disclosure system and mechanism is established in accordance with the Listing Rules, the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the "SFO") and domestic or foreign laws, regulations and other regulatory requirements. Since the Listing Date, the Company has strictly developed information disclosure pursuant to the regulatory requirements and expressly stipulated that the Board shall manage in uniform manner and be responsible for the Company's information disclosure. Moreover, detailed provisions in respect of the managerial responsibility of the Directors, senior management and officers in charge of branches or subsidiaries shall be made.

DIRECTORS' LIABILITY TO THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibilities for preparing the Group's consolidated financial statements in accordance with statutory requirements and applicable accounting standards. The Directors also acknowledge their responsibilities to ensure that the Group's consolidated financial statements are published in a timely manner. The Directors are not aware of any material events or conditions that may cast doubt upon the Company's ability to continue as a going concern.

REMUNERATION OF AUDITOR

For the Year, the Company has appointed Baker Tilly Hong Kong Limited, Registered Public Interest Entity Auditors, to provide the Company with auditing service and the remuneration amounted to approximately HK\$0.6 million. The responsibilities of Baker Tilly Hong Kong Limited as to the consolidated financial statements are set out on pages 53 to 55 of this annual report.

Non-audit services provided to the Group during the Year of approximately HK\$0.1 million for other non-audit services.

If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Therefore, Top Champion Industries Limited is an associate of a connected person of our Company by virtue of Rule 14A.12(1)(c) of the Listing Rules.

Our rental expenses (excluding government rates, utilities, management fees and other outgoings) in relation to the leasing of the Chai Wan Premises for the Year are approximately HK\$844,000.

The rental amounts payable by Top Mark under the Lease Agreements were determined with reference to the prevailing market rent at that time for similar premises. As disclosed in Notes 4 and 29 to the consolidated financial statements, the management estimates the amount of lifetime ECL of trade receivables individually or collectively. Except for significant balances or credit-impaired amounts which are assessed for impairment individually, the remaining trade receivables are assessed on a collective basis, grouped by shared credit risk characteristics including internal credit ratings, ageing and past due status. Estimated loss rates are based on historical observed default rates over the expected life of the debtors and are adjusted for supportable forward-looking information that is reasonable and supportable available without due costs or effort.

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

1 GENERAL INFORMATION

Yuk Wing Group Holdings Limited (the “**Company**”) was incorporated and registered as an exempted company with limited liability in the Cayman Islands under the Companies Law Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The shares of the Company are listed on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The registered office address of the Company is located at Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The principal place of business of the Company is located at Units 6505–11, 65/F, The Center, No. 99 Queen’s Road Central, Central, Hong Kong. The Directors consider that the Company’s immediate and ultimate holding company is Colour Shine Investments Limited, a private limited company incorporated in the British Virgin Islands (the “**BVI**”).

The Company is an investment holding company. The Company and its subsidiaries (collectively referred to as the “**Group**”) are principally engaged in the manufacturing and trading of down-the-hole (“**DTH**”) rockdrilling tools and trading of piling and drilling machineries and rockdrilling equipment.

3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards as issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange (the “**Listing Rules**”) and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 “Share-based Payment”, leasing transactions that are accounted for in accordance with HKFRS 16 “Leases” (“**HKFRS 16**”), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 “Inventories” or value in use in HKAS 36 “Impairment of Assets”.

綜合財務報表已根據香港會計師公會頒佈的香港財務報告準則會計準則編製。就編製綜合財務報表而言，倘合理預期有關資料將影響主要使用者的決策，有關資料即被視為重大。此外，綜合財務報表載有聯交所證券上市規則（「**上市規則**」）及香港公司條例規定的適用披露。

如下文所載的會計政策所述，綜合財務報表已在各報告期末以歷史成本為基準編製（若干按公平值計量的金融工具除外）。

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs are to be used to measure fair value in subsequent periods, and valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

Basis of consolidation

The consolidated financial statements incorporate financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Leases

The Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception of the contract. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

Non-lease components are separated from lease component and are accounted for by applying other applicable standards.

Short-term leases

The Group applies the short-term lease recognition exemption to leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. Lease payments on short-term leases are recognised as expense on a straight-line basis over the lease term.

Cash and cash equivalents

Cash and cash equivalents presented on the consolidated statement of financial position include:

- (a) cash, which comprises of cash on hand and bank balances, excluding bank balances that are subject to regulatory restrictions that result in such balances no longer meeting the definition of cash; and
- (b) cash equivalents, which comprises of short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on a first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Cost necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets including trade receivables, other receivables, deposits and bank balances which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessments are done based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of past events and current conditions at the reporting date as well as the forecast of future economic conditions.

The Group always recognises lifetime ECL for trade receivables.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. - an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if (i) it has a low risk of default, (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of 'investment grade' as per globally understood definitions.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

(iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or

(iv) Write-off policy

The Group writes off a financial asset, when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data and forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Lifetime ECL for certain trade receivables are considered on a collective basis taking into consideration past due information and relevant credit information such as forward-looking macroeconomic information.

The Group has the defined benefit plans of Long Service Payment (“**LSP**”) under the Hong Kong Employment Ordinance.

The Group’s net obligation in respect of defined benefit plans is calculated separately for each plan by estimating the amount of future benefit that employees have earned in the current and prior periods and discounting that amount. For LSP obligations, the estimated amount of future benefit is determined after deducting the negative service cost arising from the accrued benefits derived from the Group’s MPF contributions that have been vested with employees, which are deemed to be contributions from the relevant employees.

Current service cost is measured as the increase in the present value of the defined benefit obligation resulting from employee service in the current period. Net interest expense for the period is determined by applying the discount rate used to measure the defined benefit obligation at the beginning of the reporting period to the then net defined benefit liability, taking into account any changes in the net defined benefit liability during the period. Current service cost and net interest expense on the net defined benefit plans are recognised in profit or loss.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Liabilities recognised in respect of other long-term employee benefits are measured at the present value of estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date. Any changes in the liabilities' carrying amounts resulting from service cost, interest and remeasurements are recognised in profit or loss except to the extent that another HKFRS requires or permits their inclusion in the cost of an asset.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case, the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

Taxation

Income tax expense represents the sum of current and deferred tax expense.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit/loss before tax because of income or expenses that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

The Group recognises a deferred tax asset related to lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

Deferred tax asset and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Impairment assessment of trade receivables

The Group calculates ECL for the trade receivables individually or collectively. Except for significant balances or credit-impaired amounts which are assessed for impairment individually, the remaining trade receivables are assessed on a collective basis, grouped by shared credit risk characteristics including internal credit ratings, ageing and past due status. Estimated loss rates are based on historical observed default rates over the expected life of the debtors and are adjusted for supportable forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables are disclosed in Note 29 and Note 17 respectively.

As at 31 March 2026, the carrying amount of trade receivables is HK\$39,153,000 (2025: HK\$41,016,000), net of impairment loss of HK\$14,784,000 (2025: HK\$16,051,000).

A receivable is recognised by the Group when the goods are delivered to the customer's premises as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due. The normal credit term is 0 to 90 days upon delivery. The customers have neither rights of return nor rights to defer or avoid payment for the goods once they are accepted by the customers upon receipt of goods. The contracts signed with the customers are short-term and fixed price contracts.

Transaction price allocated to the remaining performance obligation for contracts with customers

Contracts with customers with unsatisfied performance obligations have original expected durations of one year or less. As permitted under HKFRS 15, the transaction prices allocated to these unsatisfied performance obligations are not disclosed.

28 CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to the shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of net debt, which includes bank and other borrowings and lease liabilities disclosed in Notes 22 and 23 respectively, net of cash and cash equivalents and equity attributable to owners of the Company, comprising share capital and reserves.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors of the Company consider the cost and the risks associated with each class of capital. Based on the recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debt or the redemption of existing debt.

A negative number below indicates a decrease in the Group's loss after tax for the year where the functional currency of the relevant group entities strengthens against the relevant foreign currency. For a 5% weakening of the functional currency of the relevant group entities, there would be an equal and opposite impact on the Group's loss after tax for the year.

Interest rate risk

The Group is exposed to fair value interest rate risk in relation to fixed-rate other borrowings and lease liabilities as disclosed in Notes 22 and 23 respectively. The management continuously monitors interest rate exposure.

The Group's cash flow interest rate risk relates primarily to variable-rate bank balances and bank borrowings as disclosed in Notes 19 and 22 respectively due to the fluctuation of the prevailing market interest rate. The Group currently does not have a policy on hedging interest rate risk. However, the management monitors interest rate exposure and will consider hedging significant interest rate risk should the need arise.

Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate bank borrowings. The analysis is prepared assuming the amount of liability outstanding at each reporting period end was outstanding for the whole year. A 100 basis point increase or decrease is used which represents management's assessment of the reasonably possible change in interest rates. If interest rates had been 100 basis points higher/lower and all other variables were held constant, the Group's loss after tax for the year ended 31 March 2025 would increase/decrease by HK\$42,000.

Bank balances are excluded from sensitivity analysis as the directors of the Company consider that the exposure of cash flow interest rate risk arising from variable-rate bank balances is insignificant.

Equity price risk

The Group's financial assets at FVTPL include listed equity securities in Hong Kong. These listed equity securities are subject to market price risk. The management manages this exposure by maintaining a portfolio of investments with different risk profiles. Details of the financial assets at FVTPL are set out in Note 18. The management of the Group considers that the market price risk of these investments is not significant to the Group.

敏感度分析

以下敏感度分析乃根據有關浮息銀行借貸的利率風險釐定。編製分析時假設於各報告期末償還的負債金額於整個年度均未償還。上升或下跌100個基點為管理層對利率出現的合理可能變動進行的評估。倘利率上升／下跌100個基點而所有其他變量保持不變，則本集團於截至二零二五年三月三十一日止年度的除稅後虧損將增加／減少42,000港元。

由於本公司董事認為浮息銀行結餘產生的現金流量利率風險屬微不足道，故銀行結餘不包括敏感度分析。

Credit risk and impairment assessment

Credit risk refers to the risk that the Group's counterparties default on their contractual obligations resulting in financial losses to the Group. The Group's credit risk exposures are primarily attributable to trade receivables, other receivables, deposits and bank balances. The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets.

Trade receivables arising from contracts with customers

Before accepting any new customers, the Group assesses the potential customer's credit quality and defines credit limits by customer. Credit limits granted to customers are reviewed periodically. In order to minimise the credit risk, the management has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group calculates ECL for the trade receivables individually or collectively. Except for significant balances or credit-impaired amounts which are assessed for impairment individually, the remaining trade receivables are grouped under a collective assessment after considering internal credit ratings of trade debtors, ageing, repayment history and/or past due status of respective trade receivables. Estimated loss rates are based on historical observed default rates over the expected life of the debtors and are adjusted for supportable forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group has concentration of credit risk as 16% (2025: 23%) of the total gross trade receivables was due from the Group's largest customer as at 31 March 2026 and 50% (2025: 57%) of the total gross trade receivables was due from the five largest customers as at 31 March 2026.

信貸風險指本集團的對手方違反其合約責任而導致本集團蒙受財務損失的風險。本集團的信貸風險主要歸因於貿易應收款項、其他應收款項、按金及銀行結餘。本集團並無持有任何抵押品或其他信貸增強措施，以彌補其與金融資產有關的信貸風險。

與客戶簽訂合約產生的貿易應收款項

接納任何新客戶前，本集團會評估潛在客戶之信貸質素，並釐定客戶之信貸限額。我們會定期檢討授予客戶之信貸限額。為盡量減低信貸風險，管理層已委派團隊負責釐定信貸限額、信貸批准及其他監察程序，以確保採取跟進行動收回逾期債項。此外，本集團個別或集體計算貿易應收款項的預期信貸虧損。除重大結餘或信貸減值金額作個別減值評估外，其餘貿易應收款項於考慮貿易債務人的內部信貸評級、賬齡、還款記錄及／或各貿易應收款項的逾期狀況後，按集體評估分組。估計虧損率乃基於債務人於預期年期內的歷史觀察違約率估計，並就毋須花費不必要成本或精力即可獲得的合理且有證據支持的前瞻性資料作出調整。於各報告日期會重新評估歷史觀察違約率及考慮前瞻性資料的變動。就此而言，本公司董事認為，本集團的信貸風險已大幅降低。

由於貿易應收款項總額之16%（二零二五年：23%）為應收本集團於二零二六年三月三十一日最大客戶的款項及貿易應收款項總額之50%（二零二五年：57%）為應收於二零二六年三月三十一日五大客戶的款項，故本集團的信貸風險集中。

The directors of the Company make periodic individual assessment on the recoverability of other receivables and deposits based on historical settlement records, past experience, and also quantitative and qualitative information that is reasonable and supportable forward-looking information. The directors of the Company believe that there is no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. For both years ended 31 March 2025 and 2026, the Group assessed the ECL for other receivables and deposits to be insignificant and thus no loss allowance was recognised.

Bank balances

Credit risk on bank balances is limited because the counterparties are reputable banks with high credit ratings assigned by international credit agencies. The Group assessed 12m ECL for bank balances by reference to information relating to probability of default and loss given default of the respective credit rating grades published by external credit rating agencies. Based on the average loss rates, the 12m ECL on bank balances is considered to be insignificant.

Liquidity risk

Ultimate responsibility for liquidity risk management rests with the directors of the Company, which has built an appropriate liquidity risk management framework for the management's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk by maintaining adequate reserves and borrowing facilities, by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

The following tables detail the Group's remaining contractual maturity for its financial liabilities. The Group participates in a defined contribution scheme which is registered under the MPF Scheme established under the Mandatory Provident Fund Scheme Ordinance. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees. For members of the MPF Scheme, the Group contributes at the lower of HK\$1,500 per month or 5% of relevant payroll costs each month to the MPF Scheme, in which the contribution is matched by the employee. There is no forfeited contributions utilised by the Group during the year.

The employees of the Group's subsidiary in the PRC are members of a state-managed retirement benefit plan operated by the government of the PRC. The subsidiary is required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefit plan is to make the specified contributions.

Acquisition of a company

On 12 June 2026, Top Standard Limited, a wholly-owned subsidiary of the Company (the “**Purchaser**”), entered into a sale and purchase agreement (the “**Sale and Purchase Agreement**”) with Mr. Fang Haibo (the “**Vendor**”) and Mr. He Zhangxiang and Mr. He Xuebing (collectively, the “**Grantors**”), pursuant to which the Purchaser conditionally agreed to acquire, and the Vendor conditionally agreed to sell, the registered and paid-up share capital representing 65% of the equity interest in 安徽潤升電力技術有限公司 (Anhui Runsheng Electric Power Technology Co., Ltd.*) (the “**Target Company**”) at a total consideration of RMB37,500,000 (the “**Acquisition**”).

Each of the Grantors granted the Purchaser an option to acquire the remaining 35% equity interest in the Target Company (the “**Call Option**”). The Purchaser may, at any time within twelve months following the completion date, exercise all or part of the Call Option at a total exercise price of RMB20,100,000.

Completion of the Acquisition has not yet taken place as at the date of this report and remains subject to the fulfilment of conditions precedent set out in the Sale and Purchase Agreement, including relevant approvals.

The Company is still in the progress of assessing the financial impacts for the Acquisition up to the date of this report. Details of the Acquisition are set out in the Company’s announcement dated 12 June 2026.
